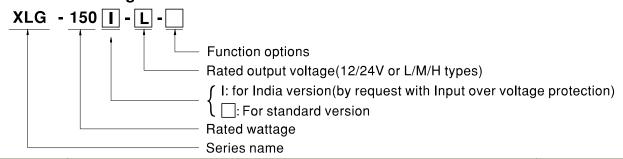

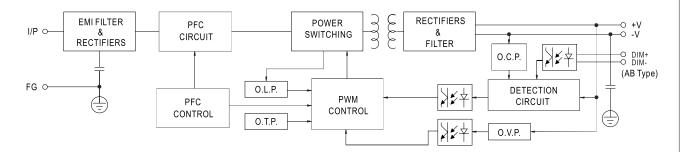

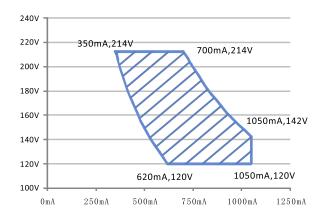
■ BLOCK DIAGRAM

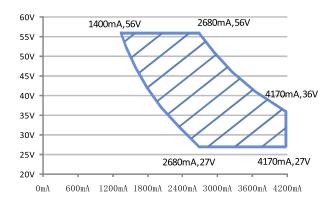


■ DRIVING METHODS OF LED MODULE

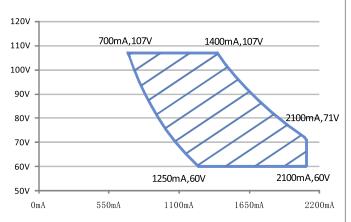

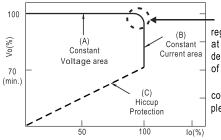

Typical output current normalized by rated current (%)

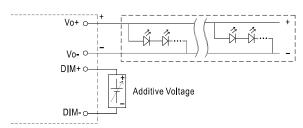
